TENANT FACES TO BE PAN-FORMED 3/16" #7328 WHITE ACRYSTEEL AND BE HELD IN PLACE WITH ZF1-1/2" RETAINERS MECHANICALLY FASTENED WITH COUNTER-SUNK SCREWS.
