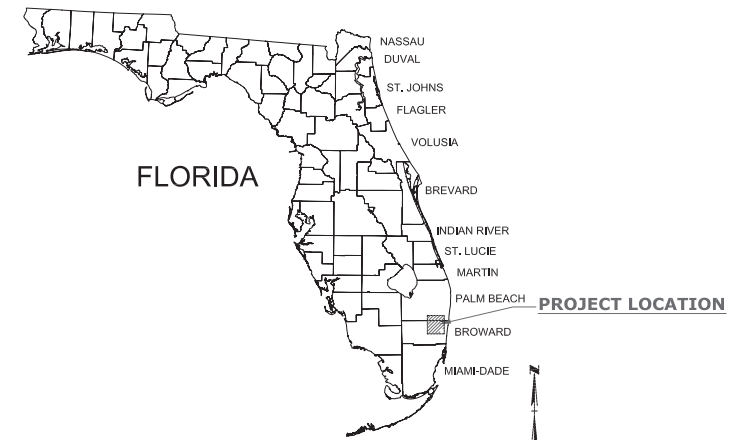


WINSTON PARK FOUNDATION TRACT H WINSTON PARK, SECTION 1 COCONUT CREEK, FLORIDA

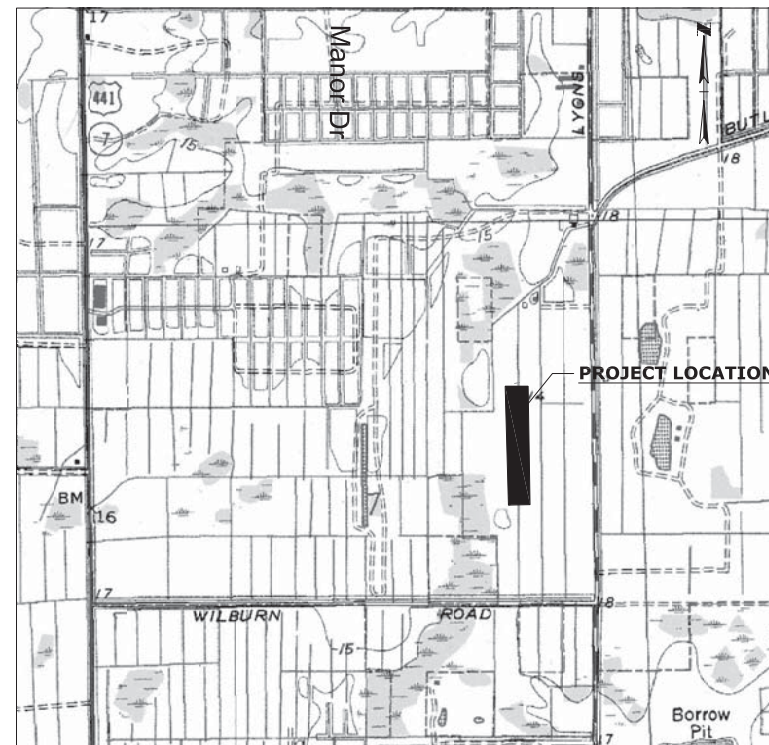
BOUNDARY SURVEY SECTION 7, TOWNSHIP 48 SOUTH, RANGE 42 EAST

LEGAL DESCRIPTION:

TRACT "H", WINSTON PARK, SECTION ONE, ACCORDING TO THE PLAT THEREOF AS RECORDED IN PLAT BOOK 131 AT PAGE 23, OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA.

BEGIN AT THE NORTHWEST CORNER OF TRACT "H"; THENCE SOUTH 0°24'54" EAST, A DISTANCE OF 1253.78 FEET TO THE POINT OF CUSP OF A CURVE CONCAVE TO THE SOUTHEAST AND HAVING A RADIUS OF 1640 FEET, TO WHICH A RADIAL LINE BEARS SOUTH 4°34'48.43" EAST AND HAVING A CHORD BEARING AND DISTANCE OF NORTH 86°17'40.89" EAST, 50.08 FEET; THENCE NORTH 0°24'54" WEST, A DISTANCE OF 13.46 FEET; THENCE NORTH 0°24'54" WEST, A DISTANCE OF 1248.32 FEET TO A POINT OF CUSP OF A CURVE CONCAVE TO THE NORTHWEST AND HAVING A RADIUS OF 2606.48 FEET, TO WHICH A RADIAL LINE BEARS SOUTH 13°15'03.34" WEST AND HAVING A CHORD BEARING AND DISTANCE OF NORTH 77°18'41.17" EAST, 51.17 FEET.
