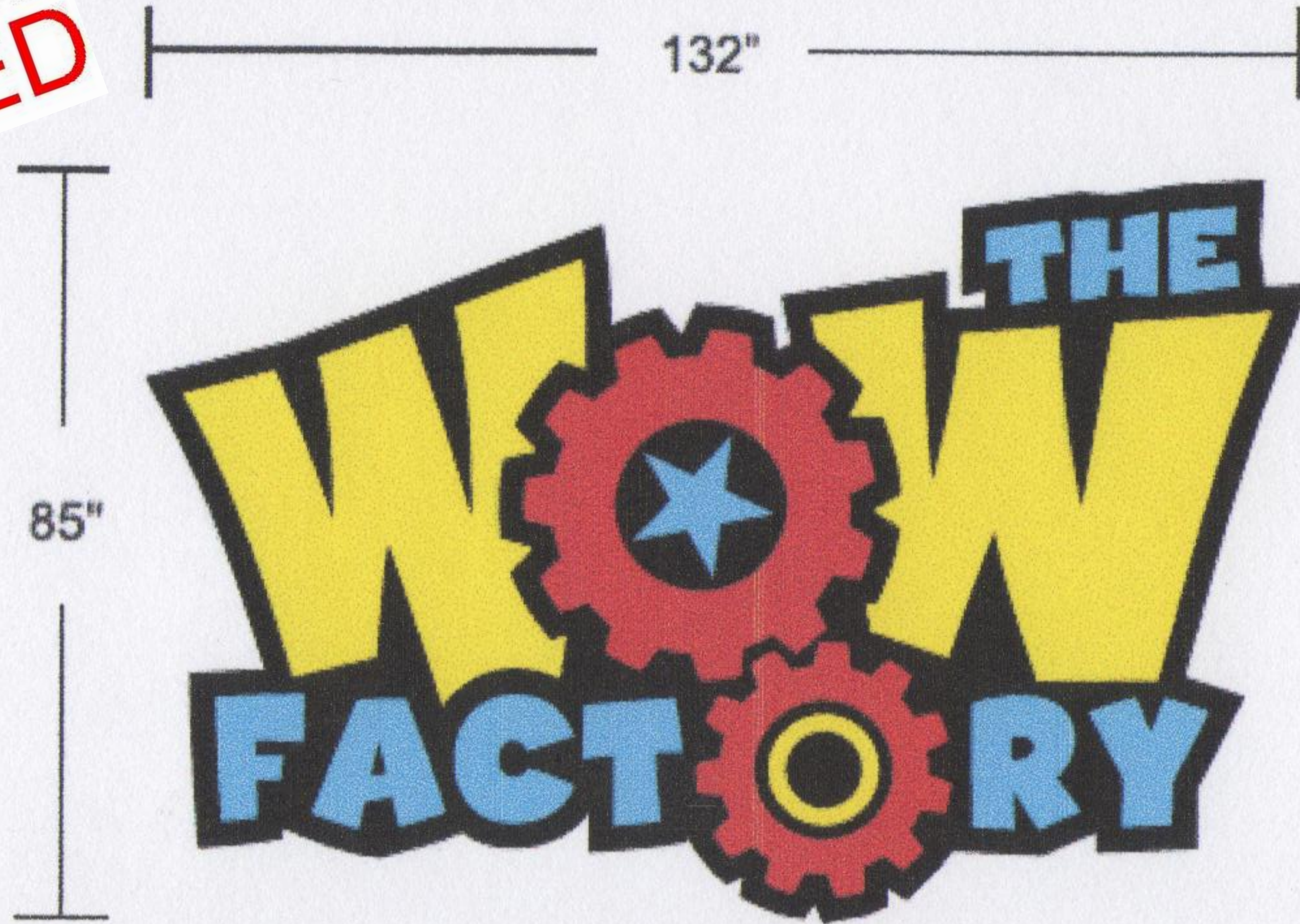

PROPOSED

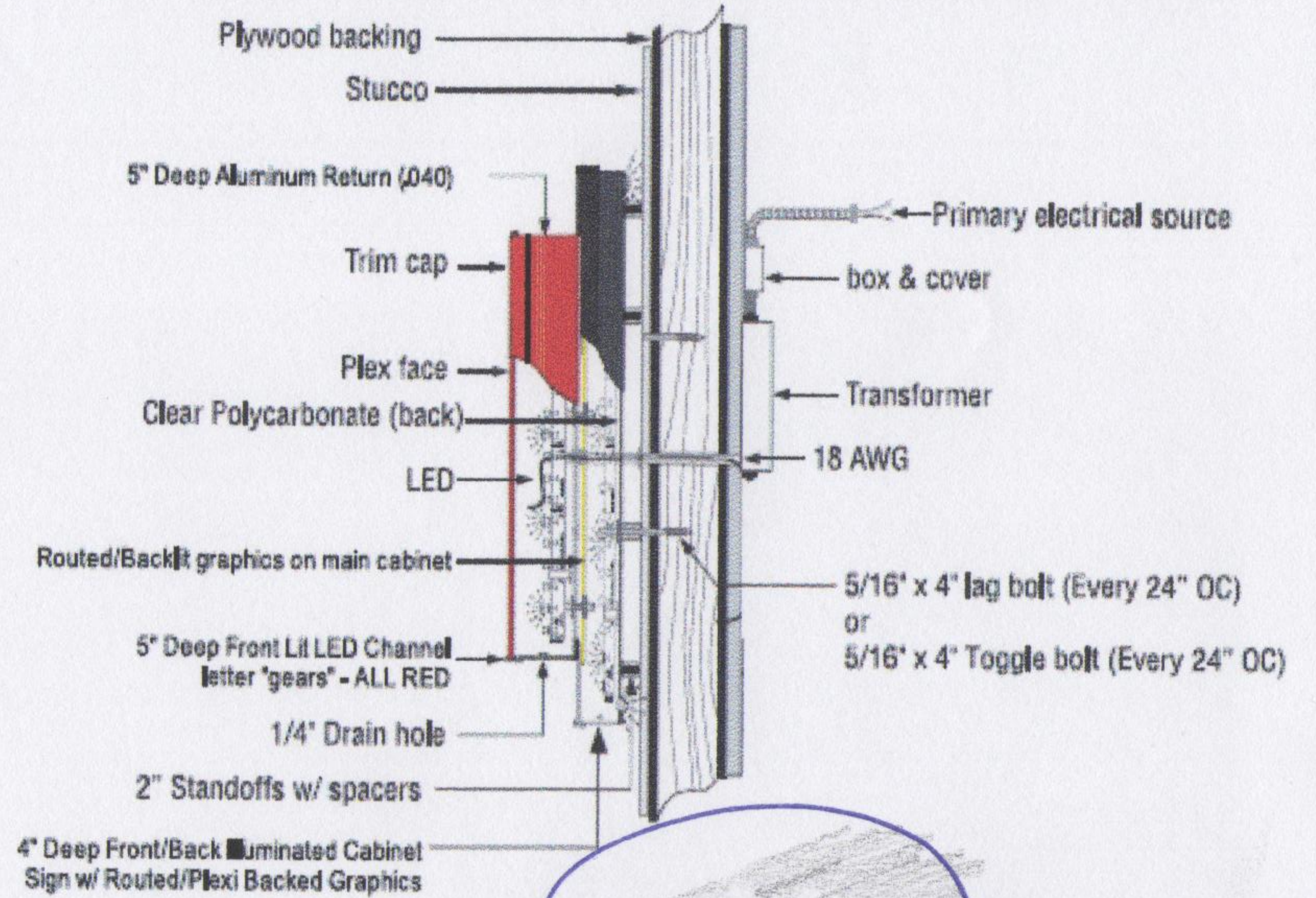
Manufacture & Install one (1) 85" x 132" LED illuminated channel letter/cabinet sign.
Sign consists of (2) front lit channel letter "gears" mounted flush to face of Routed/Plexi-backed Front & Halo Illuminated (red halo illumination) cabinet sign.
Cabinet fabricated from aluminum and finished with acrylic polyurethane.
Cabinet returns: Black
"Gear" returns: Red
Gear faces to be .177 translucent white with translucent vinyl applied 1st surface.
Cabinet faces to be .125 aluminum with routed/plexi-backed graphics.
Illumination: White LED
