DEPARTMENTAL COMMENTS

BUILDING

ENGINEERING

Conditions of Approval:

- 1. Proposed new construction (exterior wall, its footer and storefront glazing between columns at existing service drive) shall have a minimum of 6 feet horizontal separation from all existing City Utility including but not limited to water lines, water line fittings, sewer lines, sanitary clean outs, sanitary manholes, water and sewer service lines, etc.
- 2. Proposed exterior wall, its footer and store front glazing between columns etc., shall not encroach Utility Easements.

GREEN REVIEW

Contractor is responsible for any landscape that is damaged during construction and shall be restored to like or better condition.

LANDSCAPE ARCHITECTURE

Condition: contractor is responsible for any landscape that is damaged during construction and shall be restored to like or better condition.

PLANNING AND ZONING Passed Comments

- 3. Be advised that any building expansion beyond existing building footprints or new site improvements/construction will require the applicant to file new development applications





THE NEW STOREFRONT GLAZING SHALL ALSO MATCH THE EXISTING SHOWROOM BUILDING IN FRAME COLOR AND WINDOW TINT.




