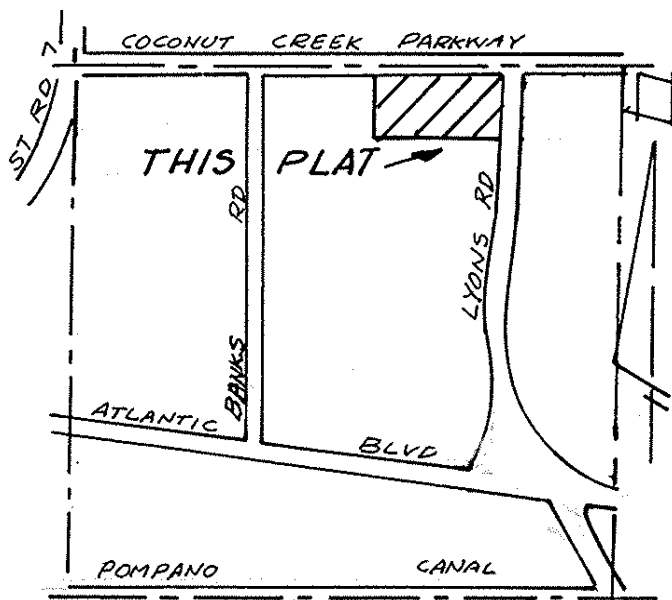

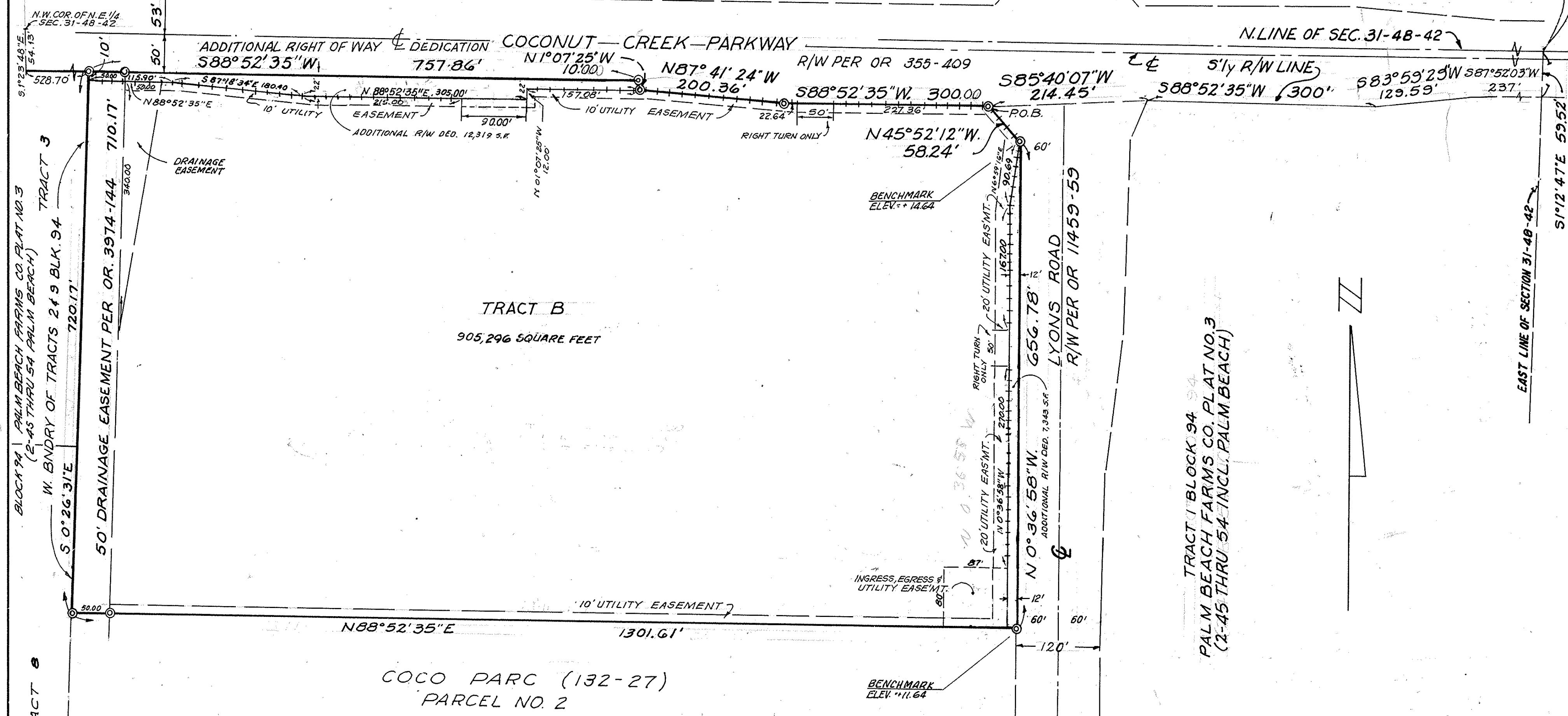


LOCATION MAP

DESCRIPTION

A PARCEL OF LAND IN THE NE 1/4 OF SECTION 31, TOWNSHIP 48 SOUTH, RANGE 42 EAST, SAID PARCEL INCLUDING PORTIONS OF TRACTS 2 AND 3 IN BLOCK 94, ACCORDING TO THE PALM BEACH FARMS COMPANY PLAT NO. 3, AS RECORDED IN PLAT BOOK 2 AT PAGES 45 THRU 54 INCLUSIVE OF THE PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTHEAST CORNER OF SAID NE 1/4 SECTION 31; THENCE RUN SOUTH 1° 12' 47" EAST (ON AN ASSUMED BEARING) 59.52 FEET ALONG THE EAST LINE OF SAID NE 1/4, TO AN INTERSECTION WITH THE SOUTHERLY RIGHT OF WAY LINE OF COCONUT CREEK PARKWAY; THENCE RUN SOUTH 87° 52' 03" WEST 237 FEET ALONG SAID SOUTHERLY RIGHT OF WAY LINE, TO A POINT OF INTERSECTION; THENCE RUN SOUTH 83° 59' 29" WEST 129.59 FEET ALONG SAID SOUTHERLY RIGHT OF WAY LINE, TO A POINT OF INTERSECTION; THENCE RUN SOUTH 88° 52' 35" WEST 300 FEET ALONG SAID SOUTHERLY RIGHT OF WAY LINE, TO A POINT OF INTERSECTION; THENCE RUN SOUTH 85° 40' 07" WEST 214.45 FEET TO THE POINT OF BEGINNING; THENCE RUN SOUTH 88° 52' 35" WEST 300 FEET ALONG SAID SOUTHERLY RIGHT OF WAY LINE OF COCONUT CREEK PARKWAY TO A POINT OF INTERSECTION; THENCE RUN NORTH 87° 41' 24" WEST 200.36 FEET ALONG SAID SOUTHERLY RIGHT OF WAY LINE, TO A POINT OF INTERSECTION; THENCE RUN NORTH 1° 07' 25" WEST 10 FEET ALONG SAID SOUTHERLY RIGHT OF WAY LINE, TO A POINT OF INTERSECTION; THENCE RUN SOUTH 88° 52' 35" WEST 757.86 FEET ALONG SAID SOUTHERLY RIGHT OF WAY LINE, TO AN INTERSECTION WITH THE WEST BOUNDARY OF SAID TRACT 2 IN BLOCK 94; THENCE RUN SOUTH 0° 26' 31" EAST 720.17 FEET ALONG SAID WEST BOUNDARY, AND THE WEST BOUNDARY OF SAID TRACT 3 IN BLOCK 94; THENCE RUN NORTH 88° 52' 35" EAST 1301.61 FEET, TO AN INTERSECTION WITH THE WESTERLY RIGHT OF WAY LINE OF LYONS ROAD, AS DESCRIBED ON THE INSTRUMENT FILED IN OFFICIAL RECORDS BOOK 114-53 AT PAGE 59 OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA; THENCE RUN NORTH 0° 36' 58" WEST 656.78 FEET ALONG SAID

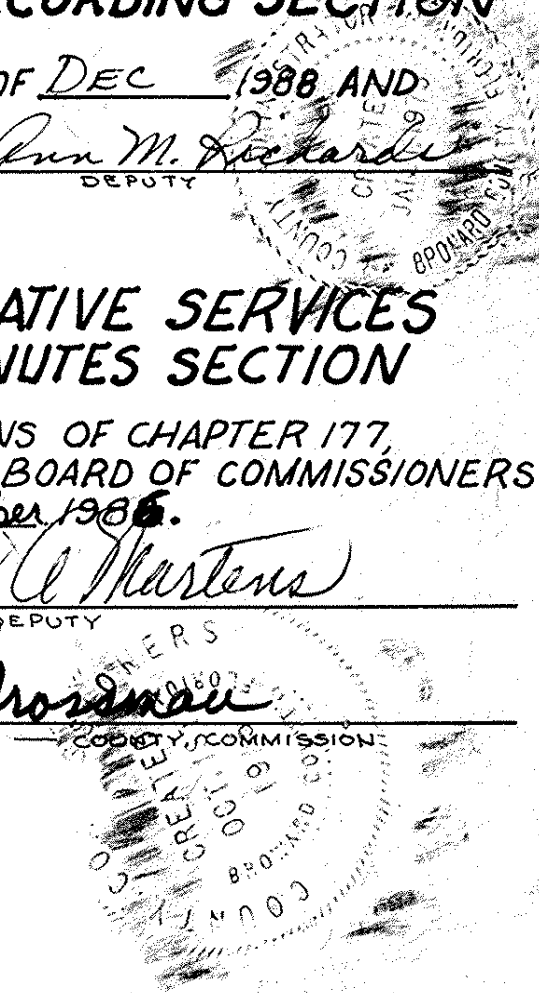
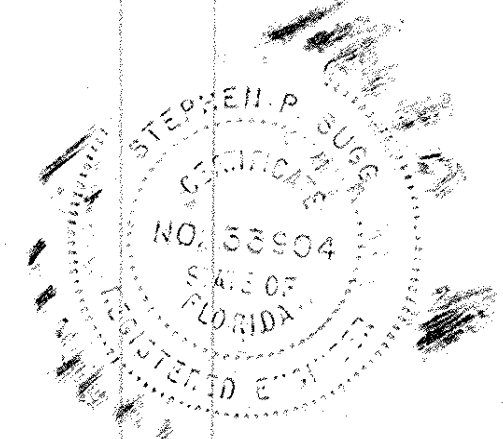
