As mentioned in our meeting, Vista BMW is in the process of acquiring permitting for the installation of new roof screen material. This material is intended for existing structures located on the attached site plan. Steelworx LLC will be the contractor applying for the permit.

There is one (1) large circular main screen above the showroom that has deteriorated due to weather conditions. The other ten (10) screens above the service bays and paint body shop are made of framed canvass. Two (2) of these ten (10) canvass frames have also suffered significant weather damage. Though only two (2) have weathered poorly, all ten (10) need to be replaced to maintain uniformity and extend longevity. Please review the attached for a visual inspection.

Vista BMW is not revising any screen locations, but simply changing the screening material to a uniform and modern material typical for this application. It will also improve the appearance.
