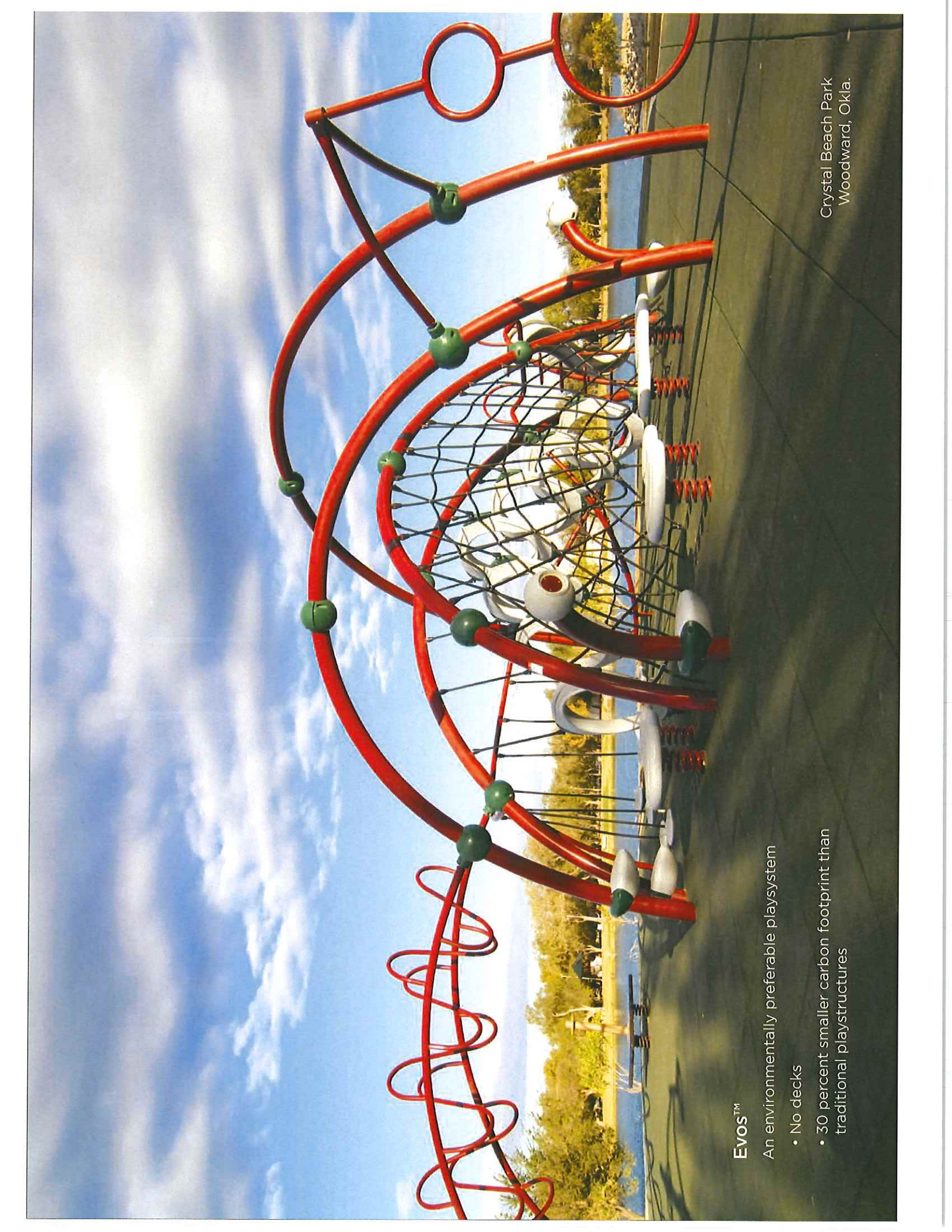

## PRODUCTS

### Our materials matter

We put a great deal of thought and research into how kids will use our products, and these insights inspire us as we design, engineer and manufacture our products. Because environmentally preferable playgrounds and skateparks are naturally better for kids, sustainability is always at the top of our list.

### Here are just a few examples:

**Our plastics contain no heavy metals.** That means you can feel good about buying rotomolded pieces such as slides and pods, knowing they are environmentally safe, and safe for kids.

**Our new ProShield™ finish is lead-free and non-toxic.** And it's so tough that it substantially increases the durability of our products! That means longer-lasting vibrant color, a glossier finish, less corrosion, fewer chips and less maintenance and replacement.

**Evos™ playsystems create a 30 percent smaller carbon footprint** than traditional playstructures, making them a particularly environmentally preferable choice that kids can't resist.

**We measure the longevity of our playstructures and other products in decades rather than years.** That makes good sense financially as well as environmentally.

Our products are designed and engineered for minimal maintenance, which means less shipping and manufacturing of replacement parts.





## PROCESSES

### Our commitments to a healthier planet

We began putting formal environmental processes in place more than 20 years ago; well before it was the critical topic it is today. We were the first playground manufacturer in North America to receive ISO 14001 certification for environmental stewardship—a distinction we've held for more than a decade. We've also been recognized as a Minnesota Waste Wise Leader for our outstanding waste reduction and recycling.

**Conservation:** Since 1998, we've saved 7,300 tons of landfill waste, 3.8 million gallons of water, 1.3 million kilowatt hours of electricity and 496,000 therms of natural gas through the implementation of innovative new processes.

**Recycling:** We reuse 90% of the scrap powder from our powdercoating process, and recycle 100% of everything that's left, to reduce landfill waste.

Not only are we recovering heat from our rotational molding process, we're using it to heat our building!

The water recycling system used in our Glass Fiber Reinforced Concrete (GFRC) manufacturing alone conserves roughly 400 gallons of water a day, or a whopping 80,000 gallons a year.

**Source Reduction:** In our manufacturing areas, we've created a single-order flow that reduces scrap production by 75% and paper use by 95%.

## PROGRAMS

### Partnering for a better future

Strategic partnerships and affiliations help us create even more opportunities to impact our communities, so we work closely with a number of like-minded organizations to ensure a healthier, more sustainable future. Two of the programs in which we participate are Global ReLeaf® and the Sustainable Sites Initiative™.

#### Global ReLeaf

A program of American Forests, Global ReLeaf plants trees around the globe to offset carbon dioxide production. With every Landscape Structures playground sale, a donation is made to

purchase enough trees to offset the carbon dioxide produced while manufacturing that specific playground. [americanforests.org](http://americanforests.org)



#### Sustainable Sites Initiative

Landscape Structures is proud to sponsor the Sustainable Sites Initiative, an interdisciplinary partnership between the American Society of Landscape Architects (ASLA), the Lady Bird Johnson Wildflower Center, the United States Botanic Garden and other organizations that is developing guidelines and standards for landscape sustainability.



Just as the U.S. Green Building Council's LEED® rating system measures a building's environmental impact, the Sustainable Sites Initiative will measure the sustainability of public, commercial and residential landscape projects. The U.S. Green Building Council is lending its support to this project and anticipates adoption of the Sustainable Sites metrics into its LEED system once they are finished.
