

- 3. THE LOCATION OF EXISTING UTILITIES AND TOPOGRAPHY HAS BEEN PREPARED FROM THE MOST RELIABLE INFORMATION AVAILABLE TO THI ENGINEER. IT IS THE CONTRACTOR'S RESPONSIBILITY TO DETERMINE THE EXACT TOPOGRAPHY AND LOCATION OF EXISTING UTILITIES PRIOR TO CONSTRUCTION SINCE TOTAL ACCURACY OF THE
- 4. PRIOR TO CONSTRUCTION, A PRE-CONSTRUCTION CONFERENCE SHALL BE HELD, WHICH WILL INCLUDE THE ENGINEER, THE CONTRACTOR, THE OWNER, THE CITY REPRESENTATIVE AND ALL UTILITY COMPANIES. THE CONTRACTOR IS TO NOTIFY THE FOLLOWING UTILITY COMPANIES, AGENCIES AND ANY OTHERS SERVING THE AREA




- 5. THE CONTRACTOR SHALL COMPLY WITH THE PROVISION OF THE FLORIDA
- 6. WORK PERFORMED FOR THIS PROJECT WILL NOT BE CONSIDERED AS COMPLETE, AND CONNECTION OF THE WATER AND SEWER SYSTEMS WILL NOT BE PERMITTED, UNTIL FINAL ACCEPTANCE OF THE SYSTEMS BY THE CITY AND UNTIL THE FOLLOWING DOCUMENTS ARE RECEIVED FROM THE CONTRACTOR AND APPROVED BY THE ENGINEER:
  - 1. CONTRACTOR'S WAIVER AND RELEASE OF LIEN.
  - 2. CONTRACTOR'S LETTER OF WARRANTY (I.E. LETTER AGREEMENT, ONE (1) YEAR GUARANTEE).
  - 3. "AS BUILT" DATA AS PREPARED BY A REGISTERED LAND
  - 4. OTHER ITEMS AS REQUIRED BY THE COCONUT CREEK ENGINEERING DEPARTMENT.
- ALL WORK WITHIN THE PUBLIC RIGHT-OF-WAY SHALL BE IN ADHERENCE TO THE STATE OF FLORIDA "MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES" (M.U.T.C.D.) AND IN ACCORDANCE WITH THE REQUIREMENTS OF THE STANDARD BROWARD COUNTY ENGINEERING DIVISION.
- 8. THE CONTRACTOR SHALL NOTIFY THE CITY AND THE ENGINEER OF RECORD AT LEAST 48 HOURS PRIOR TO BEGINNING OF CONSTRUCTION AND IN ADVANCE OF REQUIRED INSPECTIONS. TESTING WILL BE REQUIRED FOR THE FOLLOWING TASKS:
  - A. STORM DRAINAGE
    B. WATER DISTRIBUTION SYSTEM
  - C. SANITARY SEWER SYSTEM
    D. ROAD / PARKING LOT SUBGRADE
    F. FINISHED LIMEBOOK PASS
  - E. FINISHED LIMEROCK BASE
    F. ASPHALTIC CONCRETE
- ALL TESTING WILL BE WITNESSED BY THE CITY OF COCONUT CREEK.
  THE ENGINEER OF RECORD WILL PROVIDE CONSTRUCTION OBSERVATION
  SERVICES AND COPY REPORTS TO THE CITY ENGINEER ON A
  BI-WEEKLY BASIS. FINAL SITE GRADING WORK SHALL BE INSPECTED
  BY THE ENGINEER OF RECORD. EMERGENCY SITUATIONS AND CHANGE
  OF PLANS SHALL BE REPORTED AT THE TIME OF EACH OCCURRENCE.
