

Roepnack Corporation is requesting administrative approval for (4) areas of work for the Vista BMW facility located at the above mentioned address. The (4) areas of work are as follows:

- 1. Area 1 Rework the existing entry located at the North West corner of the facility to include the relocation of the existing tiger teeth and gate arms (they will both be relocated to the south to allow a greater turning radius for large vehicles.
- 2. Area 2 Rework the existing curb radius to allow fire truck access. No landscaping will be affected as the existing curbs are concrete.
- 3. Area 3 Install new (8) gate arms in the existing service drive area. The gate arms are for security purposes only. They will be used in conjunction with a porter service to allow Vista to service more cars (which will minimize car stacking) and provide security. There are currently (3) lanes of service:
 - a. The lane to the far west will be used as entry only.
 - b. The lane to the Far East will be used as an exit only.
 - c. The middle lane will be used as both entry and exit depending upon number of vehicles to be serviced. Typically it will be used as an entry in the morning and exit during the afternoon.
- 4. Area 4 will be the construction of a new 4,148 sq ft building which will be utilized to prep sold cars.
