





As you are aware, Westcreek Plaza, LLC has applied for a permit to install a directional sign within a landscape island in the parking area.

Since the most appropriate location for the sign falls within a perimeter utility easement, the purpose of this letter is to confirm that Westcreek Plaza, LLC agrees to install the sign at its own risk. Westcreek Plaza, LLC will hold the City harmless and be responsible for any damage to the sign and/or damage to any private property as well as any cost to remove or relocate the sign in the event that the sign conflicts with the proper use of the utility easement by others.

Additionally, the sign will be installed so that the footings do not exceed 24" in depth.
