Good afternoon Janet,

we reviewed the plans you emailed and for the time being these are some comments:

- 1). For the additional 1 1/2" water service lines, since they will be connected to an existing water meter and BFP, no permit will be required from the City of Margate, engineering department. The existing water meter has a credit of 1.64 W/S ERCs (1 ERC = 335 gpd) or a total of 549 gpd of maximum water usage. A year after these improvements go on line we will check the actual water use of this meter. If the maximum usage exceeds the above paid limit you will incur additional water/sewer impact fees on any usage above 549 gpd.
- 2). You will need an engineering permit for the construction of the two sewer manholes and the 400 foot, 8" PVC main between them. You will have to provide the following:
- a). Wastewater permits from Broward County and FDEP.
- b). Three signed sets of plans from a professional engineer showing the existing sewer manhole and the two new manholes and interconnecting 8" main.
- c). Provide sewer line profiles with horizontal scale of 1"=40' and vertical scale 1"=4'
- d). Provide sewer manhole and cleanout details.
- e). Show on the plans a 12 foot utility easement from the existing manhole to manhole #2. This easement will have to be dedicated to the City of Margate for future maintenance.
- f). Have the engineer double check all the rim and invert elevations.
- g). At end of construction "as built" plans (2 copies) will have to be provided to this office for our records.

I included three attachments. One is the engineering permit application which is completed by the contractor and owner and are signed and notarized. The other two attachments provide information on selecting materials for this project.

We will need an engineer's certified cost estimate associated with constructing the proposed sewer additions.

We will need three signed and sealed sets of short drawings for the manhole structures and the interconnecting

We will need three signed and sealed sets of shop drawings for the manhole structures and the interconnecting pipe, etc.

Based on the cost estimate we will prepare engineering permit fees and the amount of the bond. The bond is 125% of the above construction cost. Fees and the bond are paid at the time the permit is approved and issued.

If I left anything out will provide that information at a later time.
